JULY 1980	Water Increase 25%

10/81-04/92	Hydrant decreased from \$6.00 to \$5.00 effective January 1984					
JULY 1992	Water Increase 25% -- Assessment 50% Decrease

OCTOBER 1997	First Consumption Range for 0-1000 expanded to three ranges as follows: 0(\$0) 100-500 (\$26.50) and 501-1000 (\$39.63). A customer charge of \$2.05 will be added to each customer bill (to make up for lost revenue).					
APRIL 1998	Water Increase - 5%					
MAY 2009*	Assessment restructuring now Lineal Assessment Rate 0-600 cf = \$27.00 each additional 100 cubic feet at \$3.00 plus the \$27.00.					
MAY 2010*	Water rate restructuring 100-600 cf \$30.00, 600-1600 at 30.00 plus \$2.64 per 100 cubic feet- the remaining rates stay the same. Single unit buildings will no longer be billed Fire Protection Fee of \$5.00-- Buildings with additional units will be billed \$5.00 per unit for each additional unit. We will no longer bill customer charge of \$2.05 unless there is no water usage.					
DEC 2013	12/4/13 Board of Water Commissioners approved monthly billing rates (based on the quarterly rates for a 30 day period rather than a 90 day period) for Industrial and Institutional Accounts who are now billed monthly rather than quarterly.					
JAN 2014	1/8/14 New usage categories added for higher water usage.					
July 01, 2023	5% Water Rate Increase plus \$3.00 increase on Base Assessment Charge. 0-600 cf = \$30.00, with each additional 100 cubic feet at \$3.00 plus the \$30.00 base.
