# Approval of December 5, 2023 Minutes

### Housing Opportunity Grant Follow-up

Mr. Downie of the Barrett Planning Group shared his slideshow presentation. There was an overview of the information that has been collected from the Housing Study Interviews and the two Community Engagement Events. He then shared some slides on their Regulatory Audit which included Land Use Policy Barriers to Housing Development.

Mr. Quackenbush asked if the parking issues around the downtown area could be addressed in more detail with some recommendations. Mr. Downie will include this in the draft regulations.

An online survey will be used to collect more information from the public. It will focus on the findings listed in the Audit.

Barrett Planning will be giving drafts of specific ordinances to the Planning Board to make comments on and give feedback.

All of the work of the Barrett Planning Group will be done by July 30, 2024.

There was further discussion about including demographics in the online survey and about short term rentals. Mr. Quackenbush also asked if there could be a visual created to see where Single Families and Multi Families are located in Berlin and how it's changed over time. Ms. Barrette can work on creating a map layer to see where we are at right now, but she is unable to create anything over time.
